

### Counter-Narrative of Authoritarianism in Tunisia and its Regional Environment: Strengthening the Capacity of Noria Research's MENA Program

The demands for democracy and economic justice that brought people to the streets in many countries in North Africa and the Middle East in 2011 remain largely unmet today. On the contrary, millions of people are silenced by their governments and excluded from participation in the political, economic and social affairs of their countries. Popular calls for change continue to be met with assassinations, mass arrests, forced displacement or constant surveillance. Authoritarianism is taking over and levels of poverty and inequality are worsening.

For democracy to survive in Tunisia and the MENA region more generally - and for the populations of these countries to have a chance to live with dignity - it is imperative that those who can challenge authoritarianism do so, and do so now. This project represents the contribution of the Noria MENA program to this fight. By generating knowledge about the political, social and economic dynamics in contemporary Tunisia and mobilizing an advocacy operation to inform stakeholders about the dangers of authoritarianism across the MENA region, we fight for hope what the Arab Spring represented.

On July 25, 2021, President Kaïs Saïed took full control of the Tunisian state. Since then, he has methodically deconstructed the institutional architecture put in place after the fall of Zine El Abidine Ben Ali. His regime is also rolling back the advances in rights and freedoms that the 2010-2011 revolution had made it possible to obtain. Moreover, unlike other authoritarian formations, it does so without offering prosperity in exchange for a limitation of freedoms. Quite the contrary: the daily life of Tunisians has deteriorated considerably under Saïed, marked by repeated shortages of basic necessities and high inflation.

Despite everything, Saïed remains popular and his re-election in 2024, in the event of a presidential election, seems almost certain. On the other hand, Saïed's institutional project does not yet benefit from great popular support, as numerous intermediate consultations reveal. How to understand this paradox?

The Tunisian parliament continues its work to rewrite the law on associations. Although information is scarce, it appears that a bill submitted by a group of ten members of parliament on October 10 is the basis of these efforts. If the legislation in question is adopted by the Assembly of Representatives of the Tunisian People and ends up on the president's desk, it will introduce significant restrictions on the creation, activity and financing of associations. The most immediate consequence, it will considerably hamper the work of NGOs in the country.

Tunisian President Kaïs Saïed appears to have adopted a "just say no" strategy when dealing with powerful financial partners. Regardless of the economic difficulties facing his country and the immediate benefit that foreign currency loans could bring, the President is, for the moment, looking for another exit route. All this raises a number of questions: Can Tunisia afford Saied's strategy? Do the President and his government have alternative solutions to those of the IMF, the EU and other international institutions such as the World Bank? Is Saied at risk of being caught by his bluff and driving a very fragile and struggling economy to the brink of collapse?

On July 28, 2021, Tunisian President Kais Saied welcomed Samir Majoul, President of the Tunisian Union of Industry, Commerce and Crafts (UTICA). The meeting was one of several organized by Kais Saied in the wake of his coup, aimed at securing buy-in from major social groups as he begins the transition to a new political regime. Establishing an understanding with the national capital was considered particularly important by the President: The economy had long been in free fall, the public health crisis precipitated by Covid - including the 4th wave of summer 2021 was the deadliest in Tunisia - having only accelerated its fall. In the eyes of public opinion, businesses, like the political class, have not played their role in getting the country out of its difficulties. The article returns to the nature of Tunisian capitalism in order to explore the relationship that the Tunisian president has built with national capital.

The Tunisian agrarian sector is supported by an informal and largely feminized workforce, known as "Amilat". In the wake of the 2011 revolution, the plight of the Amilat has become a rallying point for human rights, women's rights and rural activists of all stripes. Overrepresented in the interior regions of the country, the 'Amilat' rarely seek to work in agriculture out of personal conviction, attachment to the land or even a desire to stay in rural areas.



Rather, they do so because employment opportunities in their developmentally disadvantaged background are limited. Most of those who fall into this category are also responsible for maintaining a household, have to deal with sick or absent husbands and fathers, or have spouses who work in equally precarious jobs.



Ten years after the start of the reign of Abel Fateh el-Sisi and while five more have just been secured, the Egyptian economy remains mired in a dragging crisis. In some ways, this is a crisis born of the global financial system. Ultimately, however, it is the result of a senseless policy.

Closed round table, Chatham House rule: "Understanding and responding to the challenges of Kaïs Saïed's Tunisia", October 26, 2023, Irish Cultural Center, Paris

Tunisia is facing a triple political, economic and social crisis which is difficult to see how it could be resolved in the short term. The media silence surrounding it and the absence of a concrete international response risk both accelerating the country's confinement in a hopeless situation and reinforcing a model of cooperation focused primarily on migration and security issues.

This conference was an opportunity to contribute to the public and political debate through a detailed analysis of the Tunisian situation and to discuss the concrete modalities of responses to these challenges. It brought together academics, experts, journalists, civil society actors and decision-makers

3 training programs were offered to young researchers in 2023:

#### Round tables

Noria launched its round tables to listen to the young research being done. These monthly meetings allow doctoral students to present their work and discuss their investigation techniques with more experienced colleagues. In a caring scientific framework, Noria supports young doctoral students in training in the craft of research: field investigation, construction of a scientific analysis and dissemination in innovative formats. Since their creation, more than 70 young researchers have presented their work in five major regions of the world, including 8 in 2023:

#### **Scholarships**

Noria organized the fifth 2022-2023 edition of field grants for young researchers, amounting to €1000 each. These grants support researchers who carry out an investigation in a field considered difficult and/or whose work develops strong methodological reflection and/or who carry out an original publication project in order to promote their work.

#### The 2023 laureates

Rakiétou Mamadou Ouattara: "A professional group facing African urban development: training, positioning and strategy of Nigerien, Burkinabé and Malian architects in their country"

The objective of this research is to analyze the strategies deployed by sub-Saharan architects, individually and collectively, to participate in debates and the construction of West African cities. The idea would be to study the operating conditions of little-known national players in the West African real estate industry, whose arrival on the market can have a huge impact on the middle classes, and shape the future of cities of the South. This work would make it possible to reposition architects individually and collectively in debates on urban production, to highlight their communication, advocacy and visibility strategies in their missions.





Claudia Howald: Memory and post-memory practices of Afro-Colombian urban youth in the Colombian Pacific

In the current context of Colombia, which seeks to evolve into an uncertain society after the peace agreement, the collaborative and intimate ethnographic research project focuses on young Afro-Colombians in the Chocó department (Pacific region). The project seeks to understand what it means to be young, to be born in a context of war and at the crossroads of multiple historical exclusions, by considering the memory and post-memory stories of Afro-Colombian youth in the city of Quibdó.

Samir Abdelli: "Believe, know, say. An intellectual history of Islam through the prism of the commitment of Eva de Vitray-Meyerovitch (1909-1999)"

His research focuses on an intellectual history of contemporary Islam in France during the second half of the 20th century and deals with scholarly circles linked to Islam through the prism of the case study of the intellectual and religious trajectory of Eva de Vitray -Meyerovitch, a French intellectual known for her work on Sufism, public figure of conversion to Islam and buried near the Rumi mausoleum in Konya.

Jennifer Howe: "Women cadres of the Khmer Rouge, 1975-1979: Understanding women's participation in collective violence"

Female members of the Khmer Rouge have been almost completely neglected by researchers, representing a missed opportunity to learn more about the dynamics of mass violence. Through interviews with more than 55 survivors of the Khmer Rouge regime, this thesis asks the following question: "how and why did women participate in the Cambodian genocide?" In doing so, the thesis highlights the diversity of women's experiences amid mass violence and offers new insights into individual motivations for participating in atrocities.



Elena Perino: "The memory of the selva: extractivism, violence and historical consciousness among the Shuar of the Ecuadorian Amazon."



My project aims to explore the impacts of mining activity in southern Ecuador on the life of a Shuar community located in the vicinity of an extractive megaproject. The study that I present continues and completes the efforts that have been made to assess the psychosocial damage caused by the violence perpetrated by companies and the State against the populations who live in mining sites, while nevertheless offering an attempt to integrate the analysis of different aspects hitherto separated or barely taken into consideration in relation to themes linked to extractivism: local conceptions linked to the environment, the body and illness and correspondences between the latter, the history of relations between national and international society and indigenous peoples and the different ways of understanding it and preserving its memory.

#### The Making of a Researcher

The year 2032 saw the launch of the third and final season of The Making of a Researcher within the Noria training department. 6 training sessions were organized. The participation rate in these training courses has been increasing, reaching on average around fifty participants per session. The Making of a Researcher contributes to expanding our network of researcher-trainers and strengthening our network of internal trainers.

The year 2023 was marked by the development of structuring editorial initiatives:

 Work on the redesign of our website, with a view to professionalization and broader dissemination of our work

The redesign of the website responds to a simple ambition: to combine the functional and the visual. Noria is proud to offer a clearer, refined site that makes it easier to read and target searches. A redesigned aesthetic to highlight all of Noria's intellectual productions and training offerings, while retaining its identity which focuses on immersion in the field with originality: photos, illustrations and maps.

• The development of a collective work by and for young researchers in the social sciences, to be published by Éditions Karthala in spring 2024.

This guide corresponds to the culmination of several years of training work and dissemination of field research know-how within our association, and of more than 5 years spent training young researchers and identifying their specific needs.

This researchers' manual is designed as a practical tool, a synthesis of the experiences and knowledge of our network, offering both a space for the dissemination of knowledge and skills and a practical learning tool.

Bringing together four coordinators, twenty-three authors and around thirty contributors, the development of the work was an experimental laboratory of collective work, a long-term work, crossed by long collective discussions both on the substance and on the form, having made it possible to identify the themes of the chapters and to clarify the tone of the book. The organization of a writing residency was in this respect a central time for the manual in order to confront our visions of this manual, our ways of writing, our experiences, and thus to bring the chapters into dialogue in an eminently creative movement. collective.

#### • The relaunch of a permanent editorial committee

Always in line with its original ambition to bring academic standards of research into the public sphere, Noria Research has set up a permanent editorial committee whose mission in 2023 is to deploy a new publication effort while exploring the potential of new editorial formats.

In this context, two initiatives have emerged:

#### → Publication of analyzes online and with open access

The editorial committee works with researchers and offers them the possibility of a publication which is subject to double peer review. A particular effort is made to support young researchers in writing their first publication.

#### → The launch of the SOUS-TERRAIN podcast series

Noria Research is proud to have launched original audio content that talks about social science researchers and their profession, available on all listening platforms. Each 40-minute episode highlights a researcher who takes us on a journey through their field and who tells in detail their research and their contribution to understanding social phenomena. Using first-hand sound recordings and discussions with the researcher, this podcast shows what field research in the social sciences is today. How do we actually do research? What happens during a pitch? This series offers a sound immersion in a profession that is little known and allows people to discover in a new way what the craft of research and the production of knowledge is. Some episodes are in partnership with the CEPED (Center Population and Development - IRD -University of Paris) and the CEDEJ (Center for Economic, Legal and Social Studies and Documentation).



Total amount of income 2023: €238,000 \*




