A WORD FROM THE DIRECTOR

2024, a year of achievements!

2024 was a pivotal year for Noria Research, marked by the culmination of long-standing projects and the consolidation of our research teams.

The newest addition to our research programs, the Africa Program, focused on "Contemporary Dynamics of Sub-Saharan Africa: Colonial Legacies, Political Transformations, Environmental Crises," was launched with a series of open-access seminars and aims to structure field-based research on these key issues affecting the continent.

The Mexico and Central America Program established itself as a local structure in Mexico City, with an autonomous office to continue its analysis of political violence in the region.

Thanks to an active fundraising strategy, we were able to sustain our research efforts on the MENA region, particularly through the recruitment of a scientific coordinator for the program. This allowed us to produce analyses on authoritarian regimes, economic reforms, and the impacts of austerity policies.

Our podcast series "Sous-Terrains" launched an impressive second season, scheduled to go live in February 2025. Moreover, with the continued support of public and private institutions, we sustained our training activities, scholarship programs, and workshop cycles.

2024 also marked the fruition of a longterm, collective, and deeply committed effort with the publication of the collective book "La fabrique de la thèse en sciences sociales. Guide collectif d'un exercice personnel," published by Karthala Editions and available on CAIRN. Despite the financial challenges faced by the entire nonprofit sector and the increasingly targeted attacks on academic freedoms (closed or inaccessible field sites, unstable political environments), 2025 promises to be a turning point for Noria.

In particular, we will work on the consolidation of a recruitment policy for researchers, the continuation of the production and dissemination of independent, high-quality knowledge to combat misinformation, inform public debate, and defend critical scholarship. We will also focus on developing new research valorization projects with diversified formats for dissemination and accessibility and implementing a summer school for doctoral training.

With the unwavering support of our partners and volunteers, whom we thank warmly, Noria will continue to defend independent, free, and high-quality research, accessible to the widest possible audience in a global geopolitical context marked by instability and political crises.

Launch of the new AFRICAS research program

In 2024, the association launched a new research program dedicated to Africa, bringing together researchers in human and social sciences.

This program offers rigorous analyses based on in-depth empirical investigations, aimed at shedding light on the major contemporary issues and challenges of the African continent. These reflections help to understand the major contemporary issues and challenges of the African continent in order to promote public debate and combat disinformation.

The program is structured around 5 research axes:

- 1. Colonial legacies and decolonial perspectives
- 2. Political dynamics and transformations
- 3. Conflicts and violence(s)
- 4. Risks, health and environment
- Gender and societies

Launch of the new AFRICAS research program

As part of the launch of the new Africas research program, the team is organizing a monthly research seminar, both in person and on Zoom.

This initiative has a dual purpose. On the one hand, it aims to highlight the complexities and diversities of these regions, moving beyond narratives that reduce them to broad categories (such as "Southern," "Central," "Western," or "Eastern" Africa). On the other hand, it seeks to explore Africa and the world, emphasizing and questioning the historical and contemporary connections of these regions with the rest of the globe.

The goal is to restore the continent to its rightful place, both in the type of knowledge produced and in the processes by which this knowledge is developed—processes that are often hindered by financial, political, institutional, or discriminatory barriers.

→ Houda Mzioudet analyses the policies and rhetoric of the Tunisian President when it comes to domestic migrant communities. → Colin Powers considers the character of the political regime that has been consolidated by Kais Saied over the last two and a half years. Taking a historical and comparative lens, he also lays out why the odds of a democratic restoration are quite low.

State-capital relations in Kaïs Saïed's Tunisia

By Colin Powers (October 2024)

→ The report probes the relationship between Kais Saied and the business community. After unveiling the incoherence and inconsistency of the President's engagement with capital (domestic and foreign), the report connects Saied's illogic to Tunisia's flailing economic performance. With Saied's tenure in Carthage just extended for another five years, his lack of a developmental vision is certain to grow even more consequential for the Tunisian people in the months and years ahead.

Event

Democratic and political crisis: what does the future hold for Tunisia under Kaïs Saïed? (Held in November 2024 - Closed conference that gathered 30 people: Tunisian civil society representatives, journalists, French foreign ministry officials, business leaders, and researchers)

After the sham of the October presidential elections, a reassessment of Tunisia's political and economic situation is needed, focusing on several key questions:

- How will Kaïs Saïed's second term be configured?
- What impact did his presidency have on state institutions and the legacy of the 2011 revolution?
- How did Saied strengthen his control over different sectors of the state and civil society?
- What is the state of its relations with the main interest groups, particularly those linked to security?
- How have social conditions evolved during his first term?
- What are the development prospects for Tunisia under his leadership?

The aim of this conference was to open up a space for dialogue in order to carry out the dual mission of taking stock of Kaïs Saïed's first term in office (2019-2024) and to identify the risks of political and economic crises on the eve of his second term.

Gendered impact of austerity measures on public services in Tunisia By Kais Attia (November 2024)



→ Kaïs Attia explores the consequences of austerity reforms on Tunisia's health and public transport systems. He highlights their disproportionate impact on women and suggests avenues for alternative policies.

<u>Gendered impacts of deindustrialization in the Middle East and North Africa</u> By Yasmin Dildar (December 2024)

→ Yasemin Dildar considers the acute effects that regional women have suffered as a result of industrial stagnation. Marshaling longitudinal data, she identifies when deindustrialization commenced, why it disproportionately damaged the prospects of women, and what policies governments should consider to reverse the trend.

→ Osama Diab (with Colin Powers) highlights the monetary and ecological imbalances that predispose WANA economies to structural fragilities. They warn against an over-reliance on global economic integration, which could aggravate these problems without a reorganization of the global economic system.

→ Sahar Mechmech assesses the gender equality strategies implemented by the IMF and the World Bank in the Middle East and North Africa. Examining the cases of Tunisia, Egypt, Lebanon, and Jordan, she concludes that these strategies are disappointing even by their own standards, and argues that they are structurally compromised by the lending institutions' commitment to austerity policies.

→Colin Powers probes the outlook for Israel's economy and in so doing, grants a sobering look at the country's capacity to continue down its destructive path. Highlighting Israel's strong capital markets and resilient external relations, Powers argues the country's warmaking faces few obstacles in the short to medium term. In the long term, however, he notes that divestment trends and increasing social tensions may undermine Israel's ability to pursue its current course.



The Petroyuan and the Internationalization of the Renminbi: Issues in Gulf-China Relations By Salam Al Shareef (July 2024)

→ Salam al Shareef evaluates the prospects of the Gulf's deepening economic entanglements with China. Tracing shifts in trade and investment as well as institutional developments in the domain of finance, al Shareef proposes that the petrodollar may be living on borrowed time.

Green (neo)colonialism in the Arab region

By Hamza Hamouchene (July 2024)

→ Hamza Hamouchene puts the microscope on the green transition. Probing solar and wind energy projects alongside recent efforts aimed at green hydrogen production, he explains why colonial and neoliberal logics threaten to compromise the transition in the Middle East and North Africa--and to reproduce existing power imbalances.

<u>Suspension of Palestinian labor in Israel since October 7: a turning point?</u>

By Walid Habbas (September 2024)

→ Walid's analysis centers on Israel's suspension of labor market permits for West Bank Palestinians. Diving into the motivations of Israel's policymakers, his research shows why this suspension may signal a broader (and extremely worrisome) shift in Israel's colonial strategy.

→ Gilbert Achcar considers Abu Dhabi and Qatar's divergent paths and what they mean for Palestine and the region. While at odds with one another across a number of theaters, Achcar discerns that this intra-GCC beef benefits the United States in the final instance, as it affords the latter a greater diversity of tools in advancing its agenda.

Elections in Jordan: the return of parties to the assembly

By Camille Abescat (September 2024)

→ Camille Abescat examines the reintegration of political parties into the Jordanian parliament. The article analyzes recent electoral reforms and their impact on political representation, while assessing the challenges and opportunities for the Jordanian political landscape.

<u>Living young in Halabja: leisure spaces, social infrastructure and marginalization</u> By Tom Préel (September 2024)

→ Tom Préel explores how young people in Halabja, Iraqi Kurdistan, navigate limited social infrastructure and feelings of marginalization. The study highlights the strategies these young people adopt to create spaces for socialization and belonging, despite the socioeconomic challenges they face.

The Palestinian Authority, a plausible solution for the post-Gaza period? By Xavier Guignard (November 2024)

→ Xavier Guignard furnished an update on the situation in Gaza. Specifically, Guignard assesses the viability of a "day after" presided by the Palestinian Authority (PA). Drawing attention to a host of reasons--many of which relate to the PA's widening legitimacy gap--he makes the case that a solution premised upon an unreformed PA is wishful thinking at best.

Capital and Genocide in the 21st Century

By Colin Powers (December 2024)

→Colin Powers turned the lens onto the private actors implicated in the Israeli genocide. His study generates a number of novel findings, the most significant of which concerns Wall Street's grand financial houses. In tracing those providing the arms, logistical operations, and credit flows which have sustained Israel's army and economy over the past fourteen months, Powers shows these institutions' fingerprints are everywhere.



SOUTH ASIA

Launched in 2014, Noria Research's South Asia Program (SAProg) has become an international reference in South Asian studies. Through the organization of round tables and a series of conferences in partnership with academic institutions, SAProg has built a large network of researchers in France and abroad.






We approach security as a social issue that deeply impacts people's daily lives, not merely as a public matter for the state to address. We are committed to building alliances with local and national organizations, engaging with communities, and understanding their specific contexts. Our critical methodology examines security issues in Mexico while broadening the scope of our studies to include both affected communities and the general public, always guided by a human rights approach and an intersectional feminist perspective.





Launch of an autonomous MXCA Office

This year, the Mexico & Central America (MXCA) program reached a new milestone with the opening of an autonomous office in Mexico and the recruitment of a new team, aimed at intensifying research efforts in the region. While remaining administratively and financially tied to the French association, Noria MXCA now operates as a distinct entity in Mexico, facilitating its local presence and the expansion of its fieldwork activities.





Project: Violence and political participation of women in Puebla

This project aims to develop a public policy to prevent, protect, and address political violence against women in Puebla through an intersectional approach. It is grounded in high-quality empirical research and provides recommendations to strengthen the capacities of key institutions, while improving the identification, visibility, and management of the forms of violence experienced by women in the exercise of their political rights.

This initiative was marked by three key achievements:

- A report on political violence against women, co-authored with the Working Group on Political Violence, established through workshops involving CSOs, experts, women politicians, and representatives of institutions such as the INE. This report synthesizes the challenges identified during the 2023-2024 electoral process.
- The co-production of a campaign for the INE's pilot protection program for women candidates during the 2024 elections, aimed at raising awareness and strengthening prevention measures.
- A policy brief titled "Women and Political Violence in Puebla" (scheduled for publication in February 2025), based on qualitative research conducted during the elections, including interviews and field observations.

As part of these efforts, the results were also presented at various stages during key moments, including at the Tec de Monterrey campus in Puebla (November 2024) and at an event organized by the INE (National Electoral Institute) for the International Day for the Elimination of Violence Against Women.

The round tables

Noria launched its roundtables to keep up with new research in the making. The monthly meetings allow students to present on their work and to discuss their research techniques with more experienced colleagues. Noria supports young researchers in a constructive environment in order to train them in various research practices, such as field studies, structuring of scientific analyses, and publication in innovative formats.



Collective work

Publication of the edited volume La fabrique de la thèse. Guide collectif d'un exercice personnel (Mangon, Garapon, Jeanmougin, Judell, 2024) by Karthala Editions.

This unconventional guide aims to provide doctoral students with the essential knowledge (usually scattered and informal) to navigate the academic environment. La fabrique de la thèse is a practical, collective guide, written by early-career researchers for early-career researchers, offering a behind-the-scenes look at this academic exercise. A wide range of topics is covered, from practical aspects like funding and time management, to questions related to fieldwork and researcher relationships, as well as challenges in disseminating research, such as teaching or alternative writing approaches.

This book stands out both for its unique methodology (a collective writing process carried out by a team of fifty authors and contributors) and for the diversity of formats used (testimonies, roundtable discussions, practical guides, annotated bibliographies, and a comic strip). It thus offers both an in-depth look at the concrete and personal experiences of writing a thesis, and a collective reflection on the production of social sciences and humanities in France.

Fighting gender-based and sexual violence

Translation of texts written by Gunilla Bjeren

The collective translation from English to French of "Rape in the Field. Reflections from a survivor" and its appendix "Comments on Rape in the Field" is part of Noria Research's commitment to combating sexual and gender-based violence (SGBV), particularly in the academic and university setting. These crucial texts, written by Gunilla Bjeren (under the pseudonym Eva Moreno), address a topic of extreme sensitivity that was largely ignored at the time: the SGBV experienced by researchers in the field, especially rape. Written in 1995 and 2017 respectively, these texts remain tragically relevant because, despite the importance of these issues, there is still a significant lack of academic publications and resources addressing them.

By making these texts accessible to a French-speaking audience, we aim not only to expand the existing body of work on this critical issue, but also to broaden the reach and impact of this struggle.

This translation thus serves as a valuable educational tool for early-career researchers. It provides them with resources and perspectives to address or prevent similar situations they may encounter. By bringing these issues to the academic agenda and constantly raising awareness of their presence, we hope to contribute to a safer and more inclusive research environment.




